**Location:** Berks County Agricultural Center

**Course:** Scenic rolling countryside roads, a short portion on the Union Canal Path next to a trout stream and trail section in Blue Marsh Recreation Area.

**Entry Fee:** \$25 Adults, \$15 ages 18 and under if postmarked by December 15th.  
Afterwards and on race day: \$30 adult, \$20 student.  
Custom, one of a kind race gifts guaranteed to the first 500 runners. After that, while supplies last.

**Registration:** opens at 9:30 AM in the 4-H building.

**Awards:** Top two males, top two females, top high school teams: OPEN and FEMALE divisions.  
Top 3 runners in 5-year age groups as follows:  
14 and under, 15-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70 and over.

**High School Team Competition:** Two divisions: OPEN (all male or mixed), FEMALE (girls only). Each team member must currently be enrolled in that high school. Awards based on XC scoring (15th place earns 15 points, etc.) Lowest 3 person point total wins. Team members are also eligible for individual awards. NO ADDITIONAL COST.
